May kindly see the property statement received online from Sri Sudama Prasad, Special Judge (SC/ST, Pev.of Atroci Act), Kanpur Nagar, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2018-20 (2018-19 & 2019-20), the Gross income from salary is Rs.46,28,375/- and total deductions/savings/investment against GPF, GIS, PPF, Insurances, Loan repayment and Income Tax is Rs.22,70,004/- and the balance of his savings bank account(s) is also increased by Rs.4,81,541/- in this financial year from previous year's balance, total of which is Rs.27,51,545/-. Thus, a sum of Rs.18,76,830/- was therefore available with him to meet out the household expenditure of his family consisting five members of the financial year 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2016-18 (2016-17 & 2017-18) offline and the same has been seen by Hon'ble Mr. Justice Anil Kumar, the then Administrative Judge, Mathura Judgeship, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same for which the officer has stated in his application as attachment dated 09.12.2021 that (in his verbatim) *"due to the Covid pandemic I am also suffering from Covid Positive, property statement could not be submitted within time, So please condone the delay in submitting the property statement on time. I shall submit the property statement within time in future."*

May, therefore, if approved, property statements for the financial year 2018-20 (2018-19 & 2019-20) of Sri Sudama Prasad, Special Judge (SC/ST, Pev.of Atroci Act), Kanpur Nagar, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
