May kindly see the property statement online received from Smt. Anita Singh, Civil Judge (Senior Division)/F.T.C., Raebareli regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2019-20 & 2020-21, Total Gross income from salary is Rs.23,70,952/- and total deductions/ repayment/ savings/ investment against NPS, Car loan, LIC policies and PPF a/c are Rs.7,12,882/-. Thus, a sum of Rs.16,58,070/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.2,32,427/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is also a Judicial Officer having gross income from salary & agriculture of Rs.12,42,046/- & Rs.13,46,687/- in the financial years 2019-20 & 2020-21 respectively.

In this connection, it is submitted that officer has already submitted her property statements at the time of joining into Judicial Service and of the financial years 2017-19 which have been processed on Statement IDs 1375 and 1682 respectively.

It is also submitted that officer has requested vide High Court's online objections dated 12.01.2022 and 29.01.2022, to submit the reply of Hon'ble Court's order which has been passed in old case ID no.1591 of her Husband Sri Suryabhan Kumar Verma, so that the same may be placed before Hon'ble Court, for further orders in the matter. Then, the officer has attached "new chart" relating to her property held at the time of joining and subsequent increase in her property in the attachment dated 13.02.2022 and 17.02.2022, as separately ordered in her husband's Property statement ID no. 1591. However, related office note has also been submitted in old case ID no.1591.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements for the financial year 2019-21 firstly vide online dated 10.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-20 & 2020-21 of Smt. Anita Singh, Civil Judge (Senior Division)/ F.T.C. Raebareli be laid before Hon'ble Mr. Justice Siddharth, Administrative Judge, Raebareli for His Lordship's kind perusal and further orders?
