May kindly see the property statement online received from Smt. Sandeepa Yadav, Addl. Principal Judge, Family Court, Azamgarh regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2016-17 & 2017-18, Gross income from salary is Rs.25,63,301/- and total deductions/ repayment/ savings/ investment against NPS, GIS, PPF, Income Tax, Insurance Policy, repayment of loan and the balance of her savings bank account(s) is also enhanced for Rs.3,91,935/- this financial year from previous year's balance, total of which is Rs.22,03,376/-. Thus, a sum of Rs.3,59,925/- was therefore available with her to meet out the household expenditure of her family consisting four members for both the financial years 2016-17 & 2017-18.

It is pertinent to mention here that her husband Shri Santosh Yadav (Husband) ADJ /Spl Judge (Pocso act) Mahoba, annual income-2513730/-

In this connection, it is submitted that officer has already submitted her property statement upto the financial year 2015-16, which has already been seen by Hon'ble Ms Justice Bharati Sapru, the then Administrative Judge, Pratapgarh in Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, she stated that she could not submit the property statement in time because of health issues & covid-19 pandemic, for which he apologizes.

May, therefore, if approved, property statements for the financial years 2016-17 & 2017-18 of Smt. Sandeepa Yadav, Addl. Principal Judge, Family Court, Azamgarh be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Azamgarh Judgeship for His Lordship's kind perusal and orders?
