May kindly see the property statement submitted online dated 08.12.2021 received from Sri Subedar Singh, Special Judge (SC/ST, Pev. of Atroci Act), Jaunpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2018-20 (2018-19 & 2019-20), income from salary including arrears is Rs.47,27,317/-, and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, LIC Policy and the balance of his savings bank account(s) is also enhanced for Rs.9,44,135/- this financial year from previous year's balance, total of which is Rs.30,97,201/-. Thus, a sum of Rs.16,30,116/- was therefore available with him to meet out the household expenditure of his family consisting of four members for both the financial years 2018-20 (2018-19 & 2019-20).

In this connection it is submitted that, he has submitted his property statement upto the financial year 2016-18, which has already been processed before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Jaunpur on old case Id no-4649.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 08.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that due to busy in work and family problems, he could not submit the statement on time, for which he apologises.

May, therefore, if approved, property statements for the financial year 2018-20 (2018-19 & 2019-20) of Sri Subedar Singh, Special Judge (SC/ST, Pev. of Atroci Act), Jaunpur be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Jaunpur Judgeship for His Lordship's kind perusal and orders?
