May kindly see the online property statement received from Smt. Chhaya Nain, Addl. District & Sessions Judge, Deoria regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-19 & 2019-20, Total Gross income from salary is Rs.50,76,569/- and total deductions/ repayment/ savings/ investments (for both the financial years) against GIS, NPS, Income Tax, PPF, LIC and the balance of her savings bank account(s) has been enhanced for Rs.33,69,892/- this financial year from previous year's balance, total of which is Rs.50,61,213/-. Thus, a sum of Rs.15,356/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years. And, a sum of Rs.18,88,051/- was also available to meet out the household expenditure in the aforesaid financial year 2018-20 of officer's Husband Sri Vikash Kumar and the same has also been laid online before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Deoria Judgeship on e-Service ID 5085.

It is pertinent to mention here that her husband is also a Judicial officer and having annual income of Rs.22,79,918/- and Rs.18,51,726/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that officer has already submitted her property statement upto the financial years 2015-16 which had already been seen by Hon'ble Mrs. Justice Vijay Lakshmi, the then Administrative Judge, Hamirpur, placed in the misc. file of the officer. and of the financial years 2016-17 & 2017-18, detailed note has been submitted online before Hon'ble Mr. Justice Rajeev Singh, Administrative Judge, Deoria Judgeship for His Lordship's kind perusal and orders, on eService ID P00008842023.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-19 firstly vide offline dated 05.04.2019 & 2019-20 vide online dated 10.12.2021. As such, there is delay in submitting the property statement of the financial years 2019-20 from the part of the officer for which she has requested to consider and accept it, mentioned in officer's reply.

May, therefore, if approved, property statements of the financial year 2018-19 & 2019-20 of Smt. Chhaya Nain, Addl. District & Sessions Judge, Deoria be laid before Hon'ble Mr. Justice Rajeev Singh, Administrative Judge, Deoria Judgeship for His Lordship's kind perusal and orders?
