May kindly see the property statement online received from Sri Dinesh Kumar-II, Additional District & Sessions Judge (F.T.C.), Kushi Nagar at Padrauna regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2011-13(2011-12 & 2012-13)in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2011-13(2011-12 & 2012-13) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2011-13(2011-12 & 2012-13), Gross income from salary is Rs.11,80,861/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS/DCI, GIS, Income Tax, Insurance policies, PPF and the balance of his savings bank account(s) is also enhanced for Rs.2,44,049/- this financial year from previous year's balance is Rs.7,89,918/-. Thus, a sum of Rs.3,90,943/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that Wife of the officer is a Asst.Teacher. Her Annual Income from salary is Rs.2,40,000 Approx

In this connection, it is submitted that the officer has already submitted his property statement upto financial year 2010-11 which has already been seen by Hon'ble Mr. Justice S.N.Shukla, Administrative Judge, Bulandshahr in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2011-13(2011-12 & 2012-13)in its next financial year i.e., 2013-14 upto March 2014. He has submitted movable and immovable property statements of the financial years 2011-12 & 2012-13 firstly vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has regretted and assured that same will not be repeated in future.

May, therefore, if approved, property statements of the financial year 2011-13(2011-12 & 2012-13) of Sri Dinesh Kumar-II, Additional District & Sessions Judge (F.T.C.), Kushi Nagar at Padrauna be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushinagar at Padrauna Judgeship for His Lordship's kind perusal and orders?
