May kindly see the property statement online received from Sri Mohan Lal Vishwakarma, Principal Judge, Family Court, Deoria regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Total income from salary is Rs.51,62,243/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, LIC policy, repayment of car loan and the balance of his savings bank account(s) is enhanced by Rs.11,71,507/- this financial year from previous year's balance, total of which is Rs.38,73,040/-. Thus, a sum of Rs.12,89,203/- was available with him to meet out the household expenditure of his family consisting of six members in both of the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2017-18, which has already been seen offline by Hon'ble Mr. Justice Bachchoo Lal, the then Administrative Judge, Sonbhadra Judgeship, in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 08.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has stated that it is humbly submitted that the delay whichever is caused in timely compliance of order of Hon'ble Court is due to almost closure of Courts and offices as spread of Pandemic Covid-19.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Mohan Lal Vishwakarma, Principal Judge, Family Court, Deoria be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Deoria Judgeship for His Lordship's kind perusal and orders?
