May kindly see the online property statement received from Smt. Garima Singh, Additional Principal Judge, Family Court, Aligarh regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-19 & 2019-20, Total income from salary & allowances are Rs.25,54,888/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PPF a/c and the balance of her savings bank account(s) is enhanced for Rs.3,10,942/- this year from the previous year's balance, total of which is Rs.9,17,742/-. Thus, a sum of Rs.16,37,146/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband is also in Judicial Service in U.P.

In this connection, it is submitted that the officer has already submitted her property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Abdul Mateen, the then Administrative Judge, Aligarh, placed in the misc. file of the officer. Property statements of the financial years 2010-11 & 2011-12, 2012-13 & 2013-14, 2014-15 & 2015-16 and 2016-17 & 2017-18 have been processed on e-service IDs 4518, 4534, 4547 and 4685 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer for which she has mentioned in the remark column of movable property statement that "She had submitted its earlier statement with some delay. She seeks unconditional apology for delaying & will take care in future."

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Smt. Garima Singh, Additional Principal Judge, Family Court, Aligarh be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
