May kindly see the property statement online received from Sri Sunil Kumar-I, Special Judge (SC/ST, Pev.of Atroci Act), Moradabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross salary is Rs.43,62,785/- and total deductions/savings/repayment/investment against GPF, GIS, Income Tax, PPF, LIC, Home loan and the balance of his savings bank account(s) is also enhanced by Rs.14,09,127/- in this financial years from previous year's balance, total of which is Rs.34,33,371/-. Thus, a sum of Rs.9,29,414/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial year.

In this connection, it is submitted that the Officer has submitted his property statements upto the financial years 2016-18, which has already been processed online against Case Id: P00025622021 (Old Case Id: 4695) before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated that "due to Covid-19 pandemic situation and due to misplacement of certain bank account related documents, the same could not be sent earlier for which he conveyed his sincere apologies to Hon'ble Court and he will submit further statements within the specified time" as mentioned his attachment letter dated 10.12.2021

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Sunil Kumar-I, Special Judge (SC/ST, Pev.of Atroci Act), Moradabad be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders?
