May kindly see the property statement received online from Sri Bateshwar Kumar, Addl. Civil Judge (Sr.Div.)/ACJM., Agra, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2017-2019 (2017-18 & 2018-19), the Gross income from salary is Rs.21,59,783/- and total deductions/savings/investment against GIS, NPS, PPF, RD, Car Loan repayments, and Income Tax is Rs.11,99,938/- and the balance of his savings bank account(s) is also increased by Rs.74,693/- in this financial year from previous year's balance, total of which is Rs.12,74,631/-. Thus, a sum of Rs.8,85,152/- was therefore available with him to meet out the household expenditure of his family consisting six members of the financial year 2017-2019 (2017-18 & 2018-19).

It is pertinent to mention here that Officer's father is a farmer having annual income of Rs.60,000/-.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2015-2017 (2015-16 & 2016-17) online against Case Id: P00032172021 (Old Case Id: 5361) and the same has been processed before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 11.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, the officer stated that (in his verbatim) "Respected Sir, Please Condone delay", in the remark column.

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Sri Bateshwar Kumar, Addl. Civil Judge (Sr.Div.)/ACJM., Agra, be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
