May kindly see the property statement submitted online dated 10.12.2021 received from Sri Pawan Kumar Singh, Judge Small Causes Court, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-21(2019-20 and 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-21(2019-20 and 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-21(2019-20 and 2020-21), Gross income from salary (of both the financial years) are Rs.27,46,442/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, , PPF, SIP, Insurance policy, total of which is Rs.10,68,662/-. Thus, a sum of Rs.16,77,780/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years and the balance of his savings bank account(s) is decreased for Rs.1,94,158/- this financial year from previous year's balance,

It is pertinent to mention here that his wife is Deputy Collector having annual income of Rs.9.19 lakh approx.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-19 which had already been seen online by Hon'ble Mr. Justice Om Prakash VII, Administrative Judge, Varanasi in e-service ID no.996.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-21(2019-20 and 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21(2019-20 and 2020-21) firstly vide online dated 10.12.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial years 2019-21(2019-20 and 2020-21) of Sri Pawan Kumar Singh, Judge Small Causes Court, Varanasi be laid before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
