May kindly see the property statement online received from Sri Ramgopal Singh, Additional District & Sessions Judge, Azamgarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2014-16(2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2014-16(2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2014-16(2014-15 & 2015-16), Gross income from salary is Rs.19,92,458/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, PPF, SBI Life Policy and repayment of car loan are Rs.5,54,538/-. Thus, a sum of Rs.14,37,499/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years. And the balance of his savings bank account(s) is reduced by Rs.85,538/- this financial year from previous year's balance.

It is pertinent to mention here that his wife Smt. Renu Choudhary is in Govt. Service & her salary is 59,000/-per month.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2012-14 online and same has been processed before Hon'ble Mr. Justice Saurabh Shyam Shamshery, Administrative Judge, Azamgarh Judgeship on old case Id no-4741.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2014-16(2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements of the financial years 2014-16(2014-15 & 2015-16) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard, Officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2014-16(2014-15 & 2015-16) of Sri Ramgopal Singh, Additional District & Sessions Judge, Azamgarh be laid before Hon'ble Mr. Justice Saurabh Shyam Shamshery, Administrative Judge, Azamgarh for His Lordship's kind perusal and orders?
