In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18(2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18(2016-17 & 2017-18), Gross income from salary is Rs.23,31,322/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, SBI Life Policy and repayment of car loan and the balance of his savings bank account(s) is enhanced by Rs.6,20,459/- this financial year from previous year's balance. total of which is Rs.15,90,547/-. Thus, a sum of Rs.7,40,775/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

It is pertinent to mention here that his wife Renu Choudhary is in Govt. Service & her salary is 67,000/per month.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2014-16 online and same has been processed before Hon'ble Mr. Justice Saurabh Shyam Shamshery, Administrative Judge, Azamgarh Judgeship on old case Id no-4748.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18(2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18(2016-17 & 2017-18) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard, Officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2016-18(2016-17 & 2017-18) of Sri Ramgopal Singh, Additional District & Sessions Judge, Azamgarh be laid before Hon'ble Mr. Justice Saurabh Shyam Shamshery, Administrative Judge, Azamgarh for His Lordship's kind perusal and orders?
