May kindly see the online reply dated 20/12/2023 received from Sushri Ekta Singh-II, Addl. Civil Judge (Senior Div.), Lakhimpur Kheri, in compliance of order of Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri, in the matter of property statements held at the time of entering i.e., of joining into U.P. Judicial Service, communicated to the officer.

In this connection, it is submitted that the officer had submitted her movable & immovable property statements held at the time of entering i.e., of joining into U.P. Judicial Service, which was put up before Hon'ble the Administrative Judge, Lakhimpur Kheri through detailed office note dated 24/05/2023, on which His Lordship has been pleased to pass the following order dated 20/07/2023:

"This property statement has been submitted by the officer concerned indicating the movable properties held at the time of joining the service. Her joining is indicated as 19.12.2019 and the statement was to be submitted just after entering into service. The reasons have not been assigned by the officer concerned regarding delay in submitting the statement.

Call for a report from the officer concerned regarding delay and as to whether she has submitted her property statements for the subsequent blocks/years within time and if not, the reasons thereof."

The order of the Court had been communicated to the officer concerned on 20/07/2023.

In reply/compliance of the Hon'ble Court's Order, the officer concerned has stated that (in her verbatim):

"It is most respectfully submitted that I am seeking an unconditional apology for not submitting my first property statement at the time of entering the service. I also seek an unconditional apology for not submitting the property statement for the financial year 2020-21 and 2021-22 on time. The property statement for the financial year 2020-21 and 2021-22 has now been submitted by me. I will be vigilant in future in this regard.

It is, therefore, most humbly requested that my first movable and immovable property statement may kindly be acknowledged for kind perusal."

In reference to the above reply/report, it is hereby submitted that officer has submitted her movable and immovable property statement for the financial year 2020-2022 vide online dated 21/12/2023, against Case Id : P00009282023. After perusal, Objection has been raised that As per two year block policy, officer has to submit the property statement for the financial year 19/12/2019-31/03/2020 & 2020-21 instead of the financial year 2020-2022 and also the property statement for financial year 2021-2023.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statement held at the time of joining the U.P. Judicial Services or just after joining into U.P. Judicial Service. Her joining date is 19/12/2019. She has firstly submitted the aforesaid statement online dated 11/12/2021. As such, there is delay in submitting the aforesaid statement on the part of the officer. In this regard, officer has given the reason for delay and compliance the Hon'ble Court's order.

May therefore, if approved, movable & immovable property statement held at the time of entering i.e., of joining into U.P. Judicial service alongwith the reply/ compliance of Hon'ble Court's order, as desired by the Court in the matter, furnished by Sushri Ekta Singh-II, Addl. Civil Judge (Senior Div.), Lakhimpur Kheri, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and further orders?
