May kindly see the property statement online received from Sri. Krishna Kumar- VII, Additional Chief Judicial Magistrate, Bahraich regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Total income Rs.31,91,494/- (Gross income from salary is Rs.27,63,539/- and from other sources(FD Interest,Bank Interest, Post Office Interest, House rent and KVP Interest) is Rs.4,27,955/- and total deductions/ repayment/ savings/ investment against PPF, Car Loan EMI, Star Health Insurance, KVP, LIC, GIS, NPS, Income tax and the balance of his savings bank account(s) is enhanced by Rs.10,76,521/- this financial year from previous year's balance, total of which is Rs.26,92,053/-. Thus, a sum of Rs.4,99,441/- was available with him to meet out the household expenditure of his family consisting of Four members in both of the financial years.

It is pertinent to mention here that his wife is working as a private teacher having annual income Rs.3,00,000/-

In this connection, it is submitted that the Officer has already submitted his property statements of the 2017-18 online and same has been approved with the order to be Caution not to delay the submissions in future by the Hon'ble Mr. Justice Pankaj Bhatia, the then, Administrative Judge, Etah.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard, officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri. Krishna Kumar- VII, Additional Chief Judicial Magistrate, Bahraich be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Bahraich for His Lordship's kind perusal and orders?
