May kindly see the property statement online received from Sri Sanjay Kumar Malik, District & Sessions Judge, Siddharth Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2017-19 (2017-18 & 2018-19), his gross income from salary is Rs.44,44,607/and total deductions/Savings/investments against CPF, GIS, Income Tax, SIP, Repayment of home loan, Insurances, Kanya Vidyadhan, R.D. and PPF is Rs.19,52,979/-. The balance of Rs.17,93.545/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.42,85,173/-(Rs.24,91,628/- from salary and Rs.17,93,545/- from saving bank account) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2017-19 (2017-18 & 2018-19).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2015-17, which has been seen by Hon'ble Mr. Justice Neeraj Tiwari, the then Administrative Judge, Jhansi in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-19 (2017-18 & 2018-19) vide online dated 10.12.2021. As such, there is delay in submitting the same. In this regard, officer has apologize for delay in letter no.171/XV dated 10.04.2023 (Misc. file of the officer).
