May kindly see the property statement online received from Sri Ram Gopal Yadav, Civil Judge (Senior Division), Hardoi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), Gross income from salary Rs.9,45,294/- and total deductions/savings/ investment against GIS, Income Tax, NSC and the balance of his savings bank account(s) is also increased by Rs.33,855/- in this financial year from previous year's balance, total of which is Rs.1,21,155/-. Thus, a sum of Rs.8,24,139/- was therefore available with him to meet out the household expenditure of his family consisting four members in the both of the financial year.

It is pertinent to mention here that Officer's father Shri Ramesh, Profession - Milk Dairy and Agriculture , Monthly income -Rs. 60,000/-approx.

In this connection, it is submitted that the Officer has already submitted his property statements at the time of joining the U.P. Judicial Service online and same has been processed before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Hardoi on old case Id no-4772.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial year 2016-18 (2016-17 & 2017-18) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard, officer has stated that he could not submit the property statement earlier due to newly appointed in service and workload. For which, he tenders his sincere apology for the same.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Ram Gopal Yadav, Civil Judge (Senior Division), Hardoi be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Hardoi for His Lordship's kind perusal and orders?
