

## **Registrar(J)(Budget)**

May kindly see the property statement online received from Smt. Aparna Dev, Civil Judge (Senior Division), Muzaffarnagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2017-18 & 2018-19, Total Gross income from salary is Rs.26,71,179/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, LIC policy, PPF a/c, TDR and the balance of her savings bank account(s) is enhanced for Rs.3,27,191/- this financial year from previous year's balance, total of which is Rs.22,65,413/-. Thus, a sum of Rs.4,05,766/- was therefore available with her to meet out the household expenditure of her family consisting two members in both the financial years.

It is pertinent to mention here that her husband is Judicial Officer having monthly income of Rs.1,00,000/- and Rs.1,10,000/- in the financial years 2017-18 & 2018-19 respectively.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into Judicial Service which had already been seen by Hon'ble Mr. Justice Devi Prasad Singh, the then Administrative Judge, Bareilly Judgeship, in the misc. file of the officer. And property statement of the financial year 2009-10 to 2014-15, a detailed offline office note has been submitted before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar for His Lordship's kind perusal and order. For the property statement of the financial years 2015-17, a detailed online note has been submitted on e-Service ID 4452.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements for the financial year 2017-19 firstly vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which she has stated that "kindly forgive her for delay in submitting the property statements in time", it has been attached in the property statement of 2015-17.

May, therefore, if approved, property statements for the financial year 2017-18 & 2018-19 of Smt. Aparna Dev, Civil Judge (Senior Division), Muzaffarnagar be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders?
