May kindly see the property statements online received from Smt. Tapasya Tripathi, Additional Chief Judicial Magistrate, Ballia regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2017-19 (financial years 2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years financial year 2017-19 (financial years 2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below-

(1) In the financial years 2017-19(financial years 2017-18 & 2018-19), Total Gross salary are Rs.17,62,079/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, PPF a/c, Insurance policies, Income Tax and the balance of her savings bank account(s) is enhanced for Rs.1,65,422/- this financial year from previous year's balance, total of which is Rs.5,36,907/-. Thus, a sum of Rs.12,25,172/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years.

It pertinent to mention here that the husband of the officer Sri Sarvesh Kumar Mishra is also Judicial officer of U.P. Judicial Service.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining the U.P. Judicial Service offline, which has already been seen by Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Faizabad in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2017-19(financial years 2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial years 2017-19(financial years 2017-18 & 2018-19) vide online dated 10.12.2021. As such, there is delay in submitting the same and for which officer has stated that property statement has not been sent in time as she was occupied in fulfilling family obligations ie-taking care of her new born child .The delay in sending in property statement was not deliberate rather bonafide for which she , apoliges unconditionally.Please forgive her mistake and kindly accept her property statement. (mentioned in submission of property statement for the financial years 2019-21, old case id no.7189)

May, therefore, if approved, property statements of the financial years 2017-19(financial years 2017-18 & 2018-19) of Smt.
