May kindly see the online property statements received from Smt. Shweta Dixit, Additional District & Sessions Judge, Pilibhit regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2009-10 & 2010-11 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2009-10 & 2010-11 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2009-10 (i.e. from 11.05.2009 to 31.03.2010) & 2010-11, Total Gross salary are Rs.6,08,984/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income tax, NSC, Insurance policies, Car loan and the balance of her savings bank account(s) has been enhanced for Rs.30,000/- this financial year from previous year's balance, total of which is Rs.1,56,554/-. Thus, a sum of Rs.4,52,430/- was therefore available with her to meet out the household expenditure of her family consisting two members in both the financial years 2009-10 (i.e. from 11.05.2009 to 31.03.2010) & 2010-11.

It is pertinent to mention here that her husband is Asstt. Public Prosecutor at Delhi having annual income of Rs.4 Lac approx.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into judicial service which had already been seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Mathura, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2009-10 & 2010-11 in its next financial year i.e., 2011-12 upto March 2012. She has submitted movable and immovable property statements of the financial years 2009-10 & 2010-11 firstly vide online dated 08.12.2021. As such, there is delay in submitting the same from the part of the officer for which she has stated (in her verbatim) that "*Property Statement has been sent after joining of service. Thereafter I also sent complete property detail of these years while seeking permission for purchasing home on 7/12/2015. However I could not sent separate Property staement on time inadvertently. I am seeking humble apology for the same.I will take care in future.*" mentioned in remark column of movable proforma.

May, therefore, if approved, property statements of the financial years 2009-10 & 2010-11 (2009-11) of Smt. Shweta Dixit, Additional District & Sessions Judge, Pilibhit be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders?
