May kindly see the property statements online received from Sri Mohammad Arif, Judicial Magistrate, Saharanpur regarding submission of statement of movable and immovable properties acquired/held by his or any member of his family for the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by his are given below.

(1) In the financial years 2018-20(2018-19 & 2019-20) , gross income from salary Rs.21,21,384/- and total deductions/Savings/ investment against SBI Life insurance policy,PPF, Income Tax, GIS, NPS are Rs.4,48,199/-. Thus, a sum of Rs.16,73,185/- was therefore available with him to meet out the household expenditure of his family consisting of two members for both the financial years. And the balance of his savings bank account(s) is also decreased for Rs.94,623/- this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statements at the time of joining into U.P. Judicial Service online against Case id- P00010742021 (Old Case id - 3165) and same has been processed before the Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Saharanpur for His Lordship's kind perusal and orders?

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that "due to Covid 19 pandemic he himself along with his family members suffered with corona by which he fails to submit his property statement on time. he feel extremely sorry for the delay caused. he will further submit property statement in future on time".

May, therefore, if approved, property statements for the financial years 2019-21(2019-20 & 2020-21) of Sri Mohammad Arif, Judicial Magistrate, Saharanpur be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders?
