May kindly see the property statement received from Sri Suyash Prakash Srivastava, Special Judge (SC/ST, Pev.of Atroci Act), Budaun, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2012-14 (2012-13 & 2013-14) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2012-14 (2012-13 & 2013-14) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2012-14 (2012-13 & 2013-14), Gross salary is Rs.21,91,297/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, PPF, Insurances, mutual fund, repayment of home loan and the balance of his savings bank account(s) is enhanced for Rs.99,356/- this financial year from previous year's balance, total of which is Rs.10,25,292/-. Thus, a sum of Rs.11,66,005/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that officer's wife Smt. Madhavi Srivastava (PhD), having annual income from teaching Rs.70,000/- approx.

In this connection, it is submitted that the officer has already submitted his property statement of the financial years 2010-12, which has already been processed before Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Budaun Judgeship on old case Id no-6309.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto March 2015. He has submitted movable and immovable property statements of the financial years 2012-14 (2012-13 & 2013-14) firstly vide online dated 14.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, he has mentioned that on account of work load and work pressure and over sightedness, the officer failed to submit the statement well within time. For which, the officer tenders unconditional apology and he also assures the Hon'ble Court not to repeat such a mistake in future.

May, therefore, if approved, property statements of the financial years 2012-14 (2012-13 & 2013-14) of Sri Suyash Prakash Srivastava, Special Judge (SC/ST, Pev.of Atroci Act), Budaun, be laid before Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Budaun for His Lordship's kind perusal and orders?
