May kindly see the property statement received from Sri Prabhash Tripathi, Addl. Civil Judge (Sr.Div.)/ACJM., Rai Bareli regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2016-18 (2016-17 & 2017-18), total income from salary is Rs.9,06,756/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax and the balance of his savings bank account(s) is enhanced for Rs.73,297/- this financial year from previous year's balance, total of which is Rs.1,48,287/-. Thus, a sum of Rs.7,58,469/- was therefore available with him to meet out the household expenditure of himself in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement of at the time of joining, which had already been approved by Hon'ble Dr. Justice Kaushal Jayendra Thaker, the then Administrative Judge, Bhadohi in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer, for which he has mentioned that he could not sumbit the property statement on time due to new in service, unawareness and Corona pandemic. For which, he sincerely apologizes and assures that such mistake will not repeat in near future.

May, therefore, if approved, property statements of the financial years 2016-18 (2016-17 & 2017-18) of Sri Prabhash Tripathi, Addl.
