In the financial year 2012-2014 (2012-13 & 2013-14), the Gross income is Rs.15,06,355/- (Rs.14,91,571/-from salary including arrears and Rs.14,784/- from Interest of SB account) and total deductions/savings/investment against GIS, NPS, PPF, Insurances, Loan repayments and Income Tax is Rs.8,12,817/- and the balance of his savings bank account(s) is also increased by Rs.2,14,599/- in this financial year from previous year's balance, total of which is Rs.10,27,416/-. Thus, a sum of Rs.4,78,939/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2012-2014 (2012-13 & 2013-14).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2010-2012 (2010-11 & 2011-12) online against Case Id: P00024532021 (Old Case Id: 4584) and the same has been processed before Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2012-2014 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto March 2015. He has submitted movable and immovable property statements of the financial year 2012-2014 (2012-13 & 2013-14) vide online dated 16.12.2021. As such, there is delay in submitting the same for which the officer stated in the attachment dated 16.12.2021, that delay caused due to busyness of work and bona-fide mistake, for which he apologizes to the Hon'ble Court.
