

## **Registrar(J)(Budget)**

May kindly see the online property statements received from Smt. Shweta Dixit, Additional District & Sessions Judge, Pilibhit regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2013-14 & 2014-15 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2013-14 & 2014-15 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2013-14 & 2014-15, Total Gross income is Rs.16,04,166/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income tax, PPF, Car loan, LIC policies and the balance of her savings bank account(s) has also been enhanced for Rs.73,863/- this financial year from previous year's balance, total of which is Rs.8,26,022/-. Thus, a sum of Rs.7,78,144/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years.

It is pertinent to mention here that her husband is Asstt. Public Prosecutor at Delhi having annual income of Rs.6.5 Lacs approx.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into judicial service which had already been seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Mathura, placed in the misc. file of the officer. And of the financial years 2009-10 & 2010-11 and 2011-12 & 2012-13, detailed online notes have been submitted on e-service ID no. P00026902021 and P00023832021 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2013-14 & 2014-15 in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial years 2013-14 & 2014-15 firstly vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer for which she has stated (in her verbatim) that "*Property Statement of these years has been sent on 07/12/2015 at the time of seeking permission to purchase home. However separate statement of these years could not be sent on time inadvertently. I am seeking humble apology in this regard. I shall take care in future*", mentioned in remark column of movable proforma .

May, therefore, if approved, property statements of the financial years 2013-14 & 2014-15 (2013-15) of Smt. Shweta Dixit, Additional District & Sessions Judge, Pilibhit be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders?
