May kindly see the property statement online received from Sri Sanjay Kumar Singh-IV, Additional Civil Judge (Junior Division), Lucknow, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Gross income from salary and other sources (for both the financial years) is Rs.16,80,827 (income from salary Rs.15,44,702/- & income from maturity amount of Life Insurance Policy No.00569244 is Rs.1,36,125/-) and total deductions/ repayment/ savings/ investment against NPS, GIS, LIC Policy, Income Tax, Loan and the balance of his savings bank account(s) is also increased for Rs.2,36,121/- this financial year from previous year's balance, total of which is Rs.9,39,734/-. Thus, a sum of Rs.7,41,093/- was therefore available with him to meet out the household expenditure of his family consisting two members for both the financial years 2018-19 & 2019-20.

It is pertinent to mention here that his wife Dr. Chitra Singh (profession: teaching) monthly income- Rs.40,000/-

In this connection, it is submitted that officer has already submitted his property statement at the time of joining, which has already been processed before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow on old case ID no-4847.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of the officer, for which, he has not given any reason.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Sri Sanjay Kumar Singh-IV, Additional Civil Judge (Junior Division), Lucknow, be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
