May kindly see the property statement received online from Sri Subhash Chandra-VIII, Special Judge (SC/ST, Pev.of Atroci Act), Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary is Rs.47,76,023/- and total deductions/savings/investment against GIS, GPF, PPF, Insurances, loan repayments and Income Tax is Rs.24,99,112/-. Thus, a sum of Rs.22,76,911/- was therefore available with him to meet out the household expenditure of his family consisting five members of the financial year 2018-2020 (2018-19 & 2019-20) and the balance of his savings bank account(s) is also decreased by Rs.52,816/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statements for the financial year 2016-2018 (2016-17 & 2017-18) online against Case Id : P00003192019 (Old Case Id : 458) and the same have been seen by Hon'ble Mr. Justice Jayant Banerji, the then Administrative Judge,Saharanpur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of officer, for which he has stated in his online reply dated 28.03.2023, that "with due respect submitted that I was in impression that I would submit the statement before March 2022. I am extremely apologetic for the delay. I shall be highly obliged."

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Subhash Chandra-VIII, Special Judge (SC/ST, Pev.of Atroci Act), Aligarh, be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
