May kindly see the property statement online received from Sri Abhinav Srivastava, Judicial Magistrate, Sitapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20(2018-19 & 2019-20), Gross income from salary is Rs.17,56,617/- and total deductions/ repayment/ savings/ investment against GIS, PPF, LIC Policy's, Max Insurance Policy's, TDS, Car Loan EMI and the balance of his savings bank account(s) is enhanced by Rs.1,19,590/- this financial year from previous year's balance, total of which is Rs.4,96,326/-. Thus, a sum of Rs.12,60,291/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

It is pertinent to mention here that his wife is posted as Judicial Magistrate, Kanpur Nagar Judgeship.

In this connection, it is submitted that the Officer has already submitted his property statements of the Joining online against case Id-P00022482021 and same has been moved before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Sitapur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same in this regard officer has stated that "Most humbly and respectfully, it is stated that due to inadvertence and some family problems during the corona period, I was unable to submit my property statement in due time. Therefore, it is most humbly requested to kindly accept my duly submitted property statement. I shall be highly grateful for your kind and sympathetic consideration".

May, therefore, if approved, property statements for the financial years 2018-20(2018-19 & 2019-20) of Sri Abhinav Srivastava, Judicial Magistrate, Sitapur be laid before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Sitapur for His Lordship's kind perusal and orders?
