May kindly see the property statement received online from Sri Vikas Chaudhary, A.C.J.M.(Railway), Mathura regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2016-18 (2016-17 & 2017-18), Gross income is Rs.19,45,224/- (from salary Rs.17,10,731/- from F.D. Rs. 2,34,493/-) and total deductions/savings/investment against GIS, Income Tax, PPF and the balance of his bank account(s) is also enhanced by Rs.10,245/- in this financial year from previous year's balance, total of which is Rs.3,93,985/-. Thus, a sum of Rs.15,51,239/- was therefore available with him to meet out the household expenditure of his family consisting two members in both of the financial years.

In this connection, it is submitted that the Officer has submitted his property statement held at the time of joining into U.P. Judicial Service and the same has been seen online against Case Id : P00012702021 by Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Mathura Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted his movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide online dated 09.12.21. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated (in his verbatim) that "It is respectfully submitted that the undersigned is a judicial officer of 2015 batch and has joined his service on 14.02.2017 and presently posted in Mathura. The undersigned was required to submit his property details at the earliest to the Hon'ble Court. However, the first year of joining went into the training at JTRI, Lucknow and his all property related documents were kept at the ancestral home of undersigned at Agra, therefore it took some time to collect the details. Besides, the newly appointed undersigned was engrossed and focused on training and adapting and learning the newly joined service which resulted in causing delay of submission of details. Details of the property are being submitted herewith. The undersigned heartedly apologises for the delay caused and humbly requests to condone the delay caused. The undersigned would be very careful in future to submit the details within time. The undersigned will be highly obliged", as mentioned by the officer in his attachment letter.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Vikas Chaudhary, A.C.J.M.(Railway), Mathura be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders?
