In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2017-19 (2017-18 & 2018-19), Total income is Rs.22,62,983/- (Gross income from salary) and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, LIC Policy, Fix Deposit, Mutual Fund (SIP), Repayment of Car Loan & the balance of his savings bank account(s) is enhanced for Rs.6,197/- this financial year against the previous year's balance, total of which is Rs.11,53,290/-. In this connection, it is submitted that the officer has already submitted her property statements of the financial years 2015-17 which has already been seen offline by Hon'ble Mr. Justice Abdul Moin, the then Administrative Judge, Unnao for His Lordship's kind perusal and orders in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial years 2017-19 (2017-18 & 2018-19) vide online dated 08.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has not mention any reason for delay.
