May kindly see the property statement online received from Smt. Pratibha Saxena-I, Addl. Principal Judge, Family Court, Agra regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2012-14 (2012-13 & 2013-14) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2012-14 (2012-13 & 2013-14) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2012-14 (2012-13 & 2013-14), her gross income from salary is Rs.21,14,136/- and total deductions/Savings/investments against Savings in Bank account, GPF, GIS, Income Tax, PPF, FD, Mutual Funds and Insurances is Rs.14,78,757/-. The balance of Rs.2,51,500/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.6,35,379/- was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2012-14 (2012-13 & 2013-14).

It is pertinent mention here that's Officer's Husband (Business) annual income was Rs.3,36,000/- for the financial years 2012-13 & 2013-14.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2010-12 (2010-11 & 2011-12) online against case id-P00025512021 (old case id-4684) and same has been processed before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto March 2015. She has submitted movable and immovable property statements for the financial years 2012-14 (2012-13 & 2013-14) vide dated 16.12.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer verbatim: "I am a cancer patient, due to excessive work pressure, health issues, family disturbance, ignorance of financial matters, loss of various records failed due to submit property statement within time. I beg for unconditional apology to Hon'ble Court."

May, therefore, if approved, property statements for the financial years 2012-14 (2012-13 & 2013-14) of Smt. Pratibha Saxena-I, Addl. Principal Judge, Family Court, Agra, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
