May kindly see the property statement online received from Smt. Astha Srivastava, presently posted as Civil Judge (Senior Division), Maharajganj regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), Total income is Rs.29,34,132/- (Gross income from salary ) and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, LIC Policy, Fix Deposit, Mutual Fund (SIP), Repayment of Car Loan & the balance of his savings bank account(s) is enhanced for Rs.3,22,168/- this financial year against the previous year's balance, total of which is Rs.25,23,435/-. Thus, a sum of Rs.4,10,697/- was available with him to meet out the household expenditure of her family consisting of four members in both of the financial years.

It is pertinent to mention here that husband of the officer Mr. Saurabh Srivastava, (C.J.M.) Annual Income Rs.15 Lacs Approx.

In this connection, it is submitted that the officer has already submitted her property statements of the financial years 2017-19 which has already been processed online before Hon'ble Mr. Justice Ajit Singh, Administrative Judge, Maharajganj for His Lordship's kind perusal and orders on old case Id no-4937.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 11.12.2021. As, there is no delay in submitting aforesaid property statements from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Smt.
