May kindly see the property statement online received from Sri Netrapal Singh, Additional District & Sessions Judge, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Gross income is Rs.38,33,320/- (Rs.37,25,625/- from salary and Rs.1,07,695/- from saving bank account interest) and total deductions/savings/ investment against Deposits in Saving Bank Account, CPS, GIS, PPF, Income Tax, Insurances and purchase of plot is Rs.44,95,009/-. Thus a sum of Rs.7,73,045/- from saving bank account withdrawal was therefore available with him to meet out the household expenditure of his family consist of four members in the financial years 2018-20 (2018-19 & 2019-20) and the balance of his savings account is also decreased for Rs.14,34,734/- this financial year from previous year balance.

In this connection, it is submitted that the Officer has already submitted his property statement up to the financial years 2017-18 offline, which has been seen by Hon'ble Hon'ble Dr. Justice Kaushal Jayendra Thaker , the then Administrative Judge, Sonbhadra Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same. In this regard, officer verbatim: "I have the honor to submit that I am sending the required details regarding statements relating to movable and immovable properties for year 2019 and 2020 i.e. up to 31-03-20 to be placed before the Hon'ble court for information. The information regarding statements for previous financial years up to 31-03-18 has already been sent to the Hon'ble court. I could not send the required particulars of property in time because of non-availability of details of movable properties and because of the limited functioning of the court due to corona pandemic. I sincerely apologize for the delay in this regard."

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Netrapal Singh, Additional District & Sessions Judge, Ghaziabad be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad Judgeship for His Lordship's kind perusal and orders?
