May kindly see the property statement online received from Sri Pradeep Kumar Shukla, Civil Judge (Senior Division), Pratapgarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019 - 2021 (2019-2020 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019 - 2021 (2019-2020 & 2020-21) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

In the financial years 2019 - 2021 (2019-2020 & 2020-21), his total income is Rs.29,49,589/- (Gross Income from salary) and total deduction/ repayment/ savings/ investment/ against NPS, G.I.S., Income Tax, LIC, P.P.F., repayment of loan are Rs.18,70,535/-. Thus, a sum of Rs.10,79,054/- was available with him to meet out the household expenditure of his family consisting of four members for the financial year 2019 - 2021 (2019-2020 & 2020-21). And the balance of his savings bank accounts is reduced for Rs.10,91,549/- this financial year from previous year's balance.

It is pertinent to mention here that his wife Smt. Vibha Mishra, Assistant Commissioner, Commercial Tax Deptt, State of U.P, Gross Annual Income for financial Year 2019-20- Rs.10,06,224/- Approx and for financial Year 2020-21 Rs. 10,35,600/-Approx.

In this connection, it is further submitted that officer has already submitted his property statement of the financial years 2017-19 which has already been seen by Hon'ble Mr. Justice Alok Singh, the then Administrative Judge, Bareilly on old case id no.1193.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2019-2021 (2019-2020 & 2020-21) in its next financial year i.e. 2021-22 upto March, 2022. He has submitted the aforesaid movable and immovable property statements vide online letter dated 09.12.2021. As such, there is no delay in submitting the aforesaid property statements from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019 - 2021 (2019-2020 & 2020-21) of Sri Pradeep Kumar Shukla, Civil Judge (Senior Division), Pratapgarh be laid before Hon'ble Mr. Justice J. J. Munir, Administrative Judge, Pratapgarh for His Lordship's kind perusal and orders?
