May kindly see the property statement online received from Smt. Asma Sultana, Additional Civil Judge (Sr.Div.)/ACJM, Shahjahanpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Total income is Rs.23,61,801/- (Gross income from salary and other sources) and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, FDR, SBI life insurance and the balance of her savings bank account(s) is enhanced by Rs.62,167/- this financial year from previous year's balance, total of which is Rs.10,22,634/-. Thus, a sum of Rs.13,39,167/- was available with her to meet out the household expenditure of her family consisting of three members in both of the financial years.

It is pertinent to mention here that her husband is posted as Civil Judge (SD), FTC, Shahjahanpur.

In this connection, it is submitted that the Officer has already submitted her property statements of the 2017-19 (2017-18 & 2018-19) online against Case Id : P00010082020 (Old Case Id : 1917) and same has been approved by the Hon'ble Mr. Justice Neeraj Tiwari, the then, Administrative Judge, Shahjahanpur.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 13.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Smt. Asma Sultana, Additional Civil Judge (Sr.Div.)/ACJM, Shahjahanpur be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Shahjahanpur for His Lordship's kind perusal and orders?
