May kindly see the property statement online received from Sri Prag Dutt Shukla, Additional Civil Judge (Senior Div.), Ramabai Nagar regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2017-19 (2017-18 & 2018-19), his gross income from salary is Rs.20,06,193/- and total deductions/Savings/investments against, NPS, GIS, Income Tax, PPF and Repayment of Car Loan are Rs.6,23,837/-. The balance of Rs.15,737/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.13,98,093/- (Rs.13,82,356/- from salary and Rs.15,737/- from saving bank account withdrawal) was therefore available for himself to meet out the household expenditure of the financial years 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of Joining in to U.P. Judicial Service offline, which had already been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Barabanki Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online dated 14.12.2021. As such, there is delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Prag Dutt Shukla, Additional Civil Judge (Senior Div.), Ramabai Nagar be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Ramabai Nagar Judgeship for His Lordship's kind perusal and orders?
