It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2010-12 (2010-11 & 2011-12) in its next financial year i.e., 2012-13 upto March 2013. He has submitted movable and immovable property statements of the financial year 2010-12 (2010-11 & 2011-12) vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that due to busy in work, he could not prepare the property statement on time, for which he sincerely apologizes. He also ensure that he will submit the same on time in future.
