May kindly see the property statement online received from Sri Malkhan Singh, District & Sessions Judge, Hapur regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), his gross income from salary and other sources is Rs.48,33,423/- (Rs.44,44,563/- from salary, Rs.2,16,739/- Maturity of FD and Rs.1,72,121/- from Income from Interest) and total deductions/Savings/investments against, NPS, GIS, Income Tax, PPF and Sunkanya Samridhhi Yojna are Rs.19,75,324/-. The balance of Rs.3,15,846/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.31,73,945/- (Rs.28,58,099/- from salary and Rs.3,15,846/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2019-21 (2019-20 & 2020-21).

It is pertinent mention here that officer wife (Teacher in Haryana Education Department) annual income was Rs.11,62,000/- for the F.Y. 2019-20 and F.Y. 2020-21 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2017-19 (2017-18 & 2018-19) offline, which had already been seen by Hon'ble The Chief Justice, High Court of Judicature at Allahabad in the Misc. File of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 09.12.2021. As such, there is no day delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Malkhan Singh, District & Sessions Judge, Hapur be laid before Hon'ble Mr. Justice Ashutosh Srivastava, Administrative Judge, Hapur Judgeship for His Lordship's kind perusal and orders?
