May kindly see the online property statement received from Smt. Shweta Dixit, Additional District & Sessions Judge, Pilibhit regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21, Total Gross income is Rs.35,51,316/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income tax, NPS, PPF, Home loan, Insurance policies and SIP are Rs.15,19,086/-. Thus, a sum of Rs.20,32,230/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years. And the balance of her savings bank account(s) has also been reduced for Rs.2,578/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is Asstt. Public Prosecutor at Delhi having annual income of Rs.15 lacs approx.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into judicial service which had already been seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Mathura, placed in the misc. file of the officer. And of the financial years 2009-10 & 2010-11, 2011-12 & 2012-13, 2013-14 & 2014-15, 2015-16 & 2016-17 and 2017-18 & 2018-19, detailed online notes have been submitted on e-service ID no. P00026902021, P00023832021, P00027192021, P00033792021 and P00034182021 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 firstly vide online dated 09.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2019-20 & 2020-21 (2019-21) of Smt. Shweta Dixit, Additional District & Sessions Judge, Pilibhit be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Pilibhit Judgeship for His Lordship's kind perusal and orders?
