

## **Registrar(J)(Budget)**

May kindly see the online property statement received from Sri Padam Narain Mishra, the then District and Sessions Judge, Ambedkar Nagar presently posted as District and Sessions Judge, Jhansi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years financial years 2018-19 & 2019-20 (financial year 2018-20) in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years financial years 2018-19 & 2019-20 (financial year 2018-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years financial years 2018-19 & 2019-20 (financial year 2018-20), total income from Salary is Rs.50,07,174/- and total deductions/ repayment/ savings/ investment (for both the financial years) against CPF/NPS, GIS, Income Tax, car loan, Home loan, Insurance policies, SIP and the balance of his savings bank account(s) is enhanced for Rs.2,39,735/- this financial year from previous year's balance, total of which is Rs.27,02,887/-. Thus, a sum of Rs.23,04,287/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife's annual income is Rs.2,40,000/- & Rs.4,11,554/- from Business & Advisor (Astrology) in the financial years 2018-19 & 2019-20 respectively and his mother's annual income is Rs.1,02,000/- from pension in the financial years 2018-19.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining which had already been seen by Hon'ble Mr. Justice Rajesh Dayal Khare, the then Administrative Judge, Banda and property statement for the financial years 2008-09 to 2013-14 had already been laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Ambedkar Nagar for His Lordship's kind perusal & order, in the misc. file of the officer. Online detailed office note related to property statement of the financial years 2014-16 & 2016-18 has already been submitted on e-service IDs 4987 & 5013 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 ( financial year 2018-20) in the next financial year i.e., 2020-21 upto March 2021. Officer has submitted the same firstly on 09.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "Due to COVID he was unable to send property statement on time.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 (financial year 2018-20) of Sri Padam Narain Mishra, District and Sessions Judge, Jhansi be laid before Hon'ble Mrs. Justice Manju Rani Chauhan, Administrative Judge, Jhansi Judgeship for Her Lordship's kind perusal and orders?
