May kindly see the property statement online received from Sri Ajay Kumar Singh-I, Presiding Officer, Motor Accident Claims Tribunal, Baghpat regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2013-15 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2013-15 (2013-14 & 2014-15). Gross income from salary and other sources is Rs. 21,76,352/- (Rs.53,121/- from Principal Tax Saver and Rs.84,881/- maturity of TATA AIG insurance policy) and total deductions/savings/ investment against GIS, PPF, Income Tax, Insurances, FDR and the balance of his savings bank account(s) is also enhanced by Rs.4,39,763/- in this financial year from previous year's balance, total of which is Rs.11,13,825/-. Thus, a sum of Rs.10,62,527/- was therefore available with him to meet out the household expenditure of his family consisting three members in the both of the financial year.

It is pertinent mention here that officer's wife saving bank account balance Rs.1,58,290/- as on 31.03.2014 and Rs.2,06,784/- as on 31.03.2015 (source practice as Advocate and investor).

In this connection, it is submitted that the Officer has already submitted his property statement at the time of Joining into U.P. Judicial Service offline and same has been processed before Hon'ble Mr. Justice Vikram D. Chauhan, Administrative Judge, Baghpat for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted firstly movable and immovable property statements for the financial year 2013-15 (2013-14 & 2014-15) vide letter dated 06.05.2016 (Offline). As such, there is delay in submitting the same. In this regard, officer stated that's delay in furnishing property statement is caused due to time taken in collection of data, family health issues, work pressure and Pandemic, he seeks apology for the delay and ensure that such things will not happen in future.

May, therefore, if approved, property statements for the financial years 2013-15 (2013-14 & 2014-15) of Sri Ajay Kumar Singh-I, Presiding Officer, Motor Accident Claims Tribunal, Baghpat be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat for His Lordship's kind perusal and orders?
