Thus a sum of Rs. 27,97,481/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-20 (2018-19 & 2019-20) and the balance of his savings account is also decreased for Rs.2,98,145/- this financial year from previous year balance.

It is pertinent mention here that Officer wife (Advocate) having annual income Rs.4,56,260/- and Rs.4,87,450/- respectively for the financial years 2018-19 & 2019-20.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2016-18, which has been seen by Hon'ble Mr. Justice K.N. Bajpayee, the then, Administrative Judge, Sitapur, in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard, officer has not given any reason
