May kindly see the property statement received from Sri Dhanendra Pratap Singh, Presiding Officer, Motor Accident Claims Tribunal, Mahoba regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial year 2015-17 (2015-16 & 2016-17), income from salary is Rs.31,00,912/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, LIC and the balance of his savings bank account(s) is enhanced for Rs.6,92,536/- this financial year from previous year's balance, total of which is Rs.15,79,363/-. Thus, a sum of Rs.21,18,488/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

It is pertinent to mention here that his wife Dr. Amrita Singh (Profession- Teaching) Annual Income about Rs. 1.5 Lacs.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2013-15, which had already been processed before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Mahoba on old case Id no-5052.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-17 (2015-16 & 2016-17) vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that the delay caused due to excess of Judicial work, covid-19 pandemic, operation and treatment of CDP of his daughter, his wife suffered from gall bladder infection and operated by physician, his brother suffered from brain hemorrhage & died after a long time treatment and he also treated himself by cardiologist, so he could not submit the same on time.

May, therefore, if approved, property statements of the financial year 2015-17 (2015-16 & 2016-17) of Sri Dhanendra Pratap Singh, Presiding Officer, Motor Accident Claims Tribunal, Mahoba be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Mahoba Judgeship for His Lordship's kind perusal and orders?
