May kindly see the property statements online received from Sri Satyendra Kumar Chaudhary, Additional Chief Judicial Magistrate, Mainpuri regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21, Total Gross salary is Rs.24,17,421/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, PPF, Insurance policies, Income Tax, NPS, PLI, and the balance of his savings bank account(s) is enhanced for Rs.6,94,495/- this financial year from previous year's balance, total of which is Rs.14,64,615/-. Thus, a sum of Rs.9,52,806/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife is Advocate having annual income of Rs.3,17,080/- in the financial year 2020-21.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service and of the financial years 2017-18 & 2018-19, which has been laid before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Mainpuri Judgeship for His Lordship's kind perusal and orders, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 vide online dated 11.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2019-20 & 2020-21 of Sri Satyendra Kumar Chaudhary, Additional Chief Judicial Magistrate, Mainpuri be laid before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Mainpuri Judgeship for His Lordship's kind perusal and orders?
