May kindly see the online property statements received from Sri Vikash Kumar-II, Additional Principal Judge, Family Court, Deoria regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.58,71,486/- (Gross income from salary is Rs.41,31,644/- and amount of FFD of Rs.17,39,842/-) total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, GVR, LIC policy, PPF, amount paid against Car purchase (related information mentioned in column no.5 & attachment) and the balance of his savings bank account(s) is enhanced for Rs.6,11,723/- this financial year from previous year's balance, total of which is Rs.39,83,435/-. Thus, a sum of Rs.18,88,051/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that his wife is also Judicial Officer having annual income of Rs.23,36,914/- and Rs.27,39,655/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that he has already submitted his property statement upto the financial year 2015-16 which has already been seen by Hon'ble Mrs. Justice Vijay Lakshmi, the then Administrative Judge, Hamirpur in the misc. file of the officer. Property statement of the financial years 2016-17 & 2017-18 has been laid online before Hon'ble Mr. Justice Rajeev Singh, Administrative Judge, Deoria Judgeship for His Lordship's kind perusal and orders on e-Service ID 5325.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial year 2018-19 firstly vide offline dated 05.04.2019 & 2019-20 vide online dated 10.12.2021. As such, there is delay in submitting the property statement of the financial years 2019-20 from the part of the officer for which he has requested to consider and accept it, mentioned in officer's reply.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Vikash Kumar-II, Additional Principal Judge, Family Court, Deoria be laid before Hon'ble Mr. Justice Rajeev Singh, Administrative Judge, Deoria Judgeship for His Lordship's kind perusal and orders?
