In this connection, it is submitted that the Officer has already submitted his property statements of the 2018-19 offline and same has been approved by the Hon'ble Mr. Justice Om Prakash-VII, the then, Administrative Judge, Ghazipur Judgeship in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 13.12.2021. As such, there is no delay in submitting the same.
