May kindly see the property statement online received from Dr. Laxmi Kant Rathaur, Special Judge (U.P. Dacoity.A.A.), Agra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Total income is Rs.44,40,452/- (Gross income from salary is Rs.43,78,452/- and from Agriculture is Rs.62,000/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, SIP's, Sukanya Samriddhi Yojna, PPF and the balance of his savings bank account(s) is enhanced by Rs.5,29,507/- this financial year from previous year's balance, total of which is Rs.27,90,548/-. Thus, a sum of Rs.16,49,904/- was available with him to meet out the household expenditure of his family consisting of Four members in both of the financial years.

It is pertinent to mention here that his wife gives tuition from which her Income is Rs.5,56,900/- in both the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2018-19 offline and same has been approved by the Hon'ble Mr. Justice Om Prakash-VII, the then, Administrative Judge, Ghazipur Judgeship in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 13.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Dr. Laxmi Kant Rathaur, Special Judge (U.P. Dacoity.A.A.), Agra be laid before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Agra for His Lordship's kind perusal and orders?
