In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2019-21 (2019-20 & 2020-21), income from salary is Rs.30,79,914/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, NPS and PPF total of which is Rs. Rs.8,35,705/-/-. Thus, a sum of Rs.22,44,209/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years and the balance of his savings bank account(s) is decreased for Rs.3,37,201/- this financial year from previous year's balance

It is pertinent to mention here that his wife is Judicial Officer having annual income of Rs.16,19,681/- & Rs.16,41,853/- per annum in the financial years 2019-20 & 2020-21 respectively.

In this connection, it is submitted that the officer has already submitted his property statements for the financial years 2017-19 which has been seen by Hon'ble Mrs. Justice Sunita Agarwal Administrative Judge, Rambai Nagar on case-id no.892.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-21 (2019-20 & 2020-21)in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 11.12.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2019-21 (2019-20 & 2020-21) of Sri Bhagat Singh, Civil Judge (Sr. Div.), Ramabai Nagar be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Ramabai Nagar Judgeship for His Lordship's kind perusal and orders?
