In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2016-18 (2016-17 & 2017-18) , Gross income from salary Rs. 26,86,825/- and total deductions/savings/ investment against NPS, GIS, Income Tax and PPF is Rs.7,66,459 . Thus a sum of Rs. 19,20,366/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2016-18 (2016-17 & 2017-18) and the balance of his savings account is also decreased for Rs.2,06,986 /- this financial year from previous year balance.

It is pertinent to mention here that Officer wife (Lecturer in Government Girls inter college) having annual income for financial year 2014-15 is Rs.6,56,700/- and financial year 2015-16 is Rs.7,34,544/- in the respective financial years.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2014-16 (2014-15 & 2015-16) online against case id-P00029422021 and same has been moved before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Barabanki for His Lordship's kind perusal and orders..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial year 2016-18 (2016-17 & 2017-18) vide online dated 10.12.2021. As such, there is delay in submitting the same. In this regard, officer has stated that's, In feburary 2018 was transferred to Bareilly on promotion as an ADJ hence due to this reason he has forgetten to file the aforesaid statement.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Amit Singh-I, Additional District & Sessions Judge, Barabanki be laid before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Barabanki for His Lordship's kind perusal and orders?
