May kindly see the property statement online received from Sri Niraj Gautam, Additional District & Sessions Judge, Agra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Total income from salary and other sources is Rs.44,73,504/- (income from salary Rs.43,39,725/- and income from Interest of S.B. & FDR Rs.1,33,779/-) and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, mutual fund, Insurances and FD, total of which is Rs.33,21,592/-. Thus, a sum of Rs.11,51,912/- was available with his to meet out the household expenditure of his family consisting of three members in both of the financial years. And the balance of his savings bank account(s) is reduced by Rs.4,04,723/- this financial year from previous year's balance.

It is pertinent to mention here that his wife Mrs. Apurwa Raj earns from private tuition, her income for F.Y. 2018-19 Rs. 1,20,250/- and for F.Y. 2019-20 Rs.2,48,000/-.

In this connection, it is submitted that the officer has already submitted his property statements of the financial years 2016-18 which is already been processed online before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Agra for His Lordship's kind perusal and orders on old case Id no.6958.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 10.12.2021. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has stated that he could not submit the property statement in time due to Corona pandemic and his transfer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Niraj Gautam, Additional District & Sessions Judge, Agra be laid before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Agra for His Lordship's kind perusal and orders?
